Pursuant to art. 69 in connection with art. 87 sec. 1 point 2b of the act of the 29th of July, 2005, on public offering and conditions for introducing financial instruments to organised trading and on public companies (Journal of Laws of 2022, item 2554) - (Act) and pursuant to art. 25o of the Banking Law Act of the 29th of August, 1997 (Journal of Laws of 2022, item 2324), Generali Powszechne Towarzystwo Emerytalne S.A. (General Pension Company; Society), managing Generali Otwarty Fundusz Emerytalny (Open Pension Fund, Generali OFE) and Generali Dobrowolny Fundusz Emerytalny (Voluntary Pension Fund, Generali DFE), headquartered in Warsaw at Senatorska Street 18, hereby notifies of the reduction by the Funds of their share in the total number of votes in Comarch S.A. (hereinafter the "Company") below the threshold of 5% of the total number of votes in this Company.

The reduction in the Funds' share in the total number of votes in the Company resulted from a share sale transaction settled on the 11th of October, 2024.

Prior to the change, Generali OFE and Generali DFE Funds jointly held 835,101 (in words: eight hundred thirty-five thousand one hundred and one) shares, representing a 5.52% stake in the Company's share capital and 835,101 (in words: eight hundred thirty-five thousand one hundred and one) votes at the Company's General Meeting of Shareholders, which constituted a 5.52% share in the total number of votes;

of this, Generali Otwarty Fundusz Emerytalny (Open Pension Fund) held 829,183 (in words: eight hundred twenty-nine thousand one hundred eighty-three) shares, representing a 5.48% stake in the Company's share capital, and 829,183 (in words: eight hundred twenty-nine thousand one hundred eighty-three) votes at the General Meeting of Shareholders, accounting for 5.48% of the total votes.

Following the settlement of the transaction, the Generali OFE and Generali DFE Funds now hold 0 (in words: zero) shares of Comarch S.A., representing a 0% stake in the Company's share capital, and 0 (in words: zero) votes at the Company's General Meeting of Shareholders, representing a 0% share in the total number of votes:

of this, Generali Open Pension Fund holds 0 (in words: zero) shares, constituting a 0% share in the Company's share capital, and 0 (in words: zero) votes at the General Meeting of Shareholders, representing a 0% share of the total votes.

There are no subsidiaries of the Fund holding shares in the Company, nor are there any persons referred to in art. 87, sec. 1, point 3(c) of the Act.
